CONNECTING WITH OTHERS PREPARING FOR THE SAME EXAM CAN PROVIDE MOTIVATION, CLARIFY DOUBTS, AND INTRODUCE DIVERSE STUDY TECHNIQUES. ONLINE FORUMS OR LOCAL STUDY GROUPS CAN BE INVALUABLE RESOURCES FOR SHARING TIPS AND RESOURCES.

MANAGE STRESS AND STAY HEALTHY

3. RECEIVE AUTHORIZATION TO TEST (ATT) CONFIRMATION.
4. SCHEDULE YOUR EXAM THROUGH THE DESIGNATED TESTING SERVICE.

BE SURE TO CHECK ANY FEES ASSOCIATED WITH THE EXAM AND LICENSING, AS THESE WILL VARY DEPENDING ON THE LICENSE TYPE.

EXAM DAY PREPARATION

THE LICENSING PROCESS IS DESIGNED TO ENSURE THAT INSURANCE AGENTS, BROKERS, AND ADJUSTERS POSSESS THE NECESSARY KNOWLEDGE TO SERVE THE PUBLIC EFFECTIVELY AND ETHICALLY.

TYPES OF INSURANCE LICENSES IN OKLAHOMA

OKLAHOMA OFFERS VARIOUS LICENSE TYPES DEPENDING ON THE LINE OF INSURANCE ONE WISHES TO SELL OR UNDERWRITE. COMMON LICENSES INCLUDE:

- LIFE INSURANCE LICENSE
- HEALTH INSURANCE LICENSE
- PROPERTY AND CASUALTY LICENSE
- ADJUSTER LICENSE
- PERSONAL LINES LICENSE

THE NUMBER OF QUESTIONS AND TIME LIMITS VARY BY LICENSE TYPE BUT GENERALLY RANGE FROM 50 TO 150 QUESTIONS WITH A TIME ALLOTMENT OF 1.5 TO 3 HOURS.

PASSING SCORES AND RETAKE POLICY

OID REQUIRES A MINIMUM PASSING SCORE, OFTEN AROUND 70%, TO OBTAIN A LICENSE. CANDIDATES WHO DO NOT PASS ON THEIR FIRST ATTEMPT MAY RETAKE THE EXAM AFTER A WAITING PERIOD, WHICH VARIES BY LICENSE CATEGORY.
