The Russian state portrays itself as defending the right of all civilizations to chart their own independent path of development and is having some success in using this logic to win allies around the world. Paul Robinson recounts how ideas of inevitable convergence once dominated Russian thought as well but were gradually pushed out by civilizational theories. He outlines where these theories came from, what they propose, and how they became popular. Russia's World Order thereby reveals the true

nature of today's New Cold War and the challenge that Russian civilizationism poses to the West.

Dealing with Russia, China, Iran and other “rogue” states is a continuing agenda for agents of the world power elites. Propaganda machines in Western capitalist governments serve to protect elite wealth by promoting military conflicts to open new regions for economic investment. Phillips warns that while continued concentration of global capital increases the profits enjoyed by the global economy's “Titans,” it also increases global inequality, starvation, and civil unrest, threatening the lives of the hundreds of millions of people living in extreme poverty. It is imperative to ask how we can reverse the concentration of Titan wealth and revitalize grassroots democracy unbridled by extreme wealth. Identifying 117 global Titans by name and exposing the networks and interests that unite them provides readers opposed to militarism and committed to economic equality with crucial tools to directly engage the power elite who endanger life on earth.

The bipolar world order, based on America and the Soviet Union, that emerged after World War II kept America's aspirations in check for about half a century, until the dissolution of the Soviet Union in 1991. During this period, America extended NATO over most of Western Europe. With the Soviet Union succeeded by an initially weak Russia, America remained the only superpower, and used NATO to further extend its influence. By 2020, NATO

expanded to most of Eastern Europe and the Balkans, presenting a growing threat to Russia. The next big target was Ukraine. In 2014, America orchestrated the toppling of Russia-leaning President Yanukovych and installed a neo-Nazi government. This resulted in widespread demonstrations against it, massacres took place in Russian-speaking cities, Crimea seceded, and Donetsk and Luhansk declared themselves autonomous republics. The government declared the demonstrators terrorists and bombed its eastern regions for 8 years. When president Zelensky decided to subdue the Donbass by military force, the two Donbass republics requested Russia's help, and on 24 February, 2022 Russian troops entered the Donbass. This was the beginning of the SMO, Russia's Special Military Operation, to protect Ukraine's Russian-speaking population against the civil war waged against them by their own government since 2014. Media reporting on the conflict was and is highly biased and selective, presenting an image often at odds with facts and crucial details needed to understand what is happening and why. This book tries to complete the picture.
