ADVANCED SIMULATION TOOLS SUCH AS SIMPHARM AND MYDISPENSE INTEGRATE AUTOMATED SCORING ALGORITHMS, EFFECTIVELY SERVING AS ANSWER KEYS THAT PROVIDE INSTANT, OBJECTIVE FEEDBACK ON PRACTICAL TASKS. THESE PLATFORMS ENHANCE LEARNING BY REPLICATING REAL-LIFE PHARMACY CHALLENGES WITHIN A CONTROLLED ENVIRONMENT.

BENEFITS AND CHALLENGES OF USING COMPETENCE ASSESSMENT TOOLS WITH ANSWER KEYS
