3. TRANSPORTATION AND HANDLING OF REMAINS

ONCE ARRANGEMENTS ARE MADE, NEPTUNE SOCIETY COORDINATES THE TRANSPORTATION OF THE DECEASED FROM THE PLACE OF DEATH (HOSPITAL, HOME, HOSPICE, ETC.) TO A LOCAL CREMATORY. 4. CREMATION PROCESS

THE CREMATION ITSELF IS PERFORMED USING HIGH-TEMPERATURE OVENS DESIGNED SPECIFICALLY FOR THIS PURPOSE. IT TYPICALLY TAKES A FEW HOURS TO COMPLETE. AFTERWARD, THE REMAINS ARE CAREFULLY COLLECTED AND PROCESSED INTO ASHES.
