TYPES OF COVERAGE YOU NEED TO KNOW

- **PROPERTY INSURANCE:** COVERS DAMAGE TO OR LOSS OF PHYSICAL ASSETS LIKE HOMES, CARS, OR BUSINESS EQUIPMENT.
- **CASUALTY INSURANCE:** FOCUSES ON LIABILITY PROTECTION, COVERING LEGAL RESPONSIBILITY FOR INJURIES OR DAMAGE CAUSED TO OTHERS.

MAKE SURE TO NOT ONLY MEMORIZE DEFINITIONS BUT ALSO UNDERSTAND HOW THESE PRINCIPLES APPLY IN REAL-WORLD

SCENARIOS.

2. POLICY STRUCTURE AND COMPONENTS

EVERY INSURANCE POLICY HAS A SPECIFIC STRUCTURE, INCLUDING DECLARATIONS, INSURING AGREEMENTS, CONDITIONS, EXCLUSIONS, AND ENDORSEMENTS. KNOWING WHAT EACH SECTION ENTAILS WILL HELP YOU QUICKLY IDENTIFY THE PURPOSE AND LIMITATIONS OF POLICIES ON THE EXAM.

- **DECLARATIONS:** BASIC INFORMATION ABOUT THE INSURED, PROPERTY, COVERAGE LIMITS, AND PREMIUMS.
- **INSURING AGREEMENT:** THE INSURER'S PROMISE TO PAY FOR COVERED LOSSES.
- **CONDITIONS:** RULES OUTLINING THE DUTIES AND RESPONSIBILITIES OF THE INSURED AND INSURER.
- **EXCLUSIONS:** SITUATIONS OR PERILS NOT COVERED BY THE POLICY.
- **ENDORSEMENTS:** AMENDMENTS THAT MODIFY THE ORIGINAL POLICY TERMS.

3. TYPES OF PROPERTY INSURANCE POLICIES

FAMILIARIZE YOURSELF WITH COMMON PROPERTY POLICIES SUCH AS:

- **HOMEOWNERS POLICY (HO-3):** PROVIDES COVERAGE FOR DWELLING, PERSONAL PROPERTY, AND LIABILITY.
- **COMMERCIAL PROPERTY POLICY:** COVERS BUSINESS BUILDINGS, EQUIPMENT, AND INVENTORY.
- **DWELLING POLICY:** DESIGNED FOR RENTAL PROPERTIES OR HOMES WITHOUT STANDARD COVERAGE.

KNOWING THE DIFFERENCES BETWEEN THESE POLICIES AND THEIR COVERAGE SCOPES IS ESSENTIAL.

4. CASUALTY INSURANCE ESSENTIALS

LIABILITY-RELATED INSURANCE IS ANOTHER SIGNIFICANT EXAM FOCUS. KEY POLICIES INCLUDE:

- **COMMERCIAL GENERAL LIABILITY (CGL):** PROTECTS BUSINESSES AGAINST CLAIMS OF BODILY INJURY AND PROPERTY DAMAGE.
- **AUTOMOBILE LIABILITY INSURANCE:** COVERS DAMAGES CAUSED BY AN INSURED VEHICLE.
- **WORKERS' COMPENSATION:** PROVIDES BENEFITS TO EMPLOYEES INJURED ON THE JOB.

UNDERSTANDING HOW THESE POLICIES WORK, THEIR LIMITS, AND EXCLUSIONS WILL GIVE YOU AN EDGE.

5. STATE INSURANCE REGULATIONS AND LICENSING

- LICENSING PROCEDURES AND CONTINUING EDUCATION REQUIREMENTS.
- UNFAIR TRADE PRACTICES AND PROHIBITED ACTS.
- STATE-SPECIFIC INSURANCE REGULATIONS AND CONSUMER PROTECTIONS.

MAKE SURE YOUR CHEAT SHEET INCLUDES STATE-SPECIFIC NOTES IF YOUR EXAM IS TAILORED TO YOUR JURISDICTION.

USE VISUAL AIDS

INCORPORATE CHARTS, TABLES, AND DIAGRAMS WHERE POSSIBLE. A SIMPLE COMPARISON TABLE BETWEEN DIFFERENT HOMEOWNERS POLICIES OR A FLOWCHART ILLUSTRATING THE CLAIMS PROCESS CAN CLARIFY COMPLICATED INFORMATION AND AID RETENTION.

ORGANIZE BY EXAM CONTENT OUTLINE

STRUCTURE YOUR CHEAT SHEET TO MIRROR THE EXAM'S CONTENT OUTLINE. THIS ALIGNMENT HELPS REINFORCE TOPICS SYSTEMATICALLY AND MAKES IT EASIER TO LOCATE INFORMATION DURING REVIEW SESSIONS.

THEREFORE, CANDIDATES SHOULD INTEGRATE CHEAT SHEETS WITHIN A BROADER STUDY PLAN THAT INCLUDES PRACTICE EXAMS, INTERACTIVE LEARNING, AND CONCEPTUAL DISCUSSIONS.
